ARTICLE 1 SITE DESCRIPTION

This is a development at 96 units across three buildings (Buildings 2, 3, and 4) at Eagles Landing, in Carson City, Nevada. These units feature affordable, new construction, multi-family housing and will serve households at 30-60% of area median income.

The site will be equipped with recreation areas, play equipment and picnic/barbeque areas and all units will have private balconies or patios. All common areas, entrances, exits, walkways and parking areas will feature 24-hour video surveillance monitoring.

Residents will have access to a Community Building that houses a resident gathering area, warming kitchen, computer center and on-site management offices. The site will provide ample on-site parking with 24-hour security camera coverage and ample exterior lighting. Plans include a solar panel array that will offset at least 20% of the total property electric consumption.

ARTICLE 2 PROJECT DESCRIPTION

Concept

NNCH calls for proposals for a commission of site-specific, interpretive works to be permanently installed in the affordable housing project Eagles Landing. Thoughtful engagement with impacted communities should be a key component of the proposal.

Custom artworks should honor collective identity, shared experiences and social change. Themes should include:

- Veteran appreciation
- Cultural history of Carson City, Nevada, and the Northern Sierras, including for indigenous people
- Depiction of regional geographical features

<u>Scope</u>

Ownership is open to all media with an emphasis on wall murals and informative, outdoor placards. Artists are responsible for conceptual development and fabrication. Floor plans are available upon request. Areas to be addressed include:

- Community Building interior
- Common areas of all three floors of the three residential buildings
- Exterior landscape

Artworks will be installed between 2025 and 2026 in three phases, as each building receives a certificate of occupancy. A finalized schedule will be determined following award.

• Qualifications and Experience

NNCH will review artist's qualifications and experience. Emphasis will be given to experience associated with the scope of work of this RFP.

• Past Performance

NNCH will review the past performance of the artist based on references and direct experience, if applicable.

• Proposal Quality

The proposal will be evaluated on communicative power of its design, the efficiencies of costs and fees as well as on the proposal's ability to address the requirements of the RLP.

• SMWBE Preference

NNCH is required to give preference to qualified minority business, women's business enterprises and labor surplus area firms.

ARTICLE 6 FEDERAL GRANT REQUIREMENTS

Offerors must be aware that the Project will be supported with a State of Nevada's Housing Division subaward, as pass-through, to NNCH, of federal funds from the U.S. Department of the Treasury's State and Local Fiscal Recovery Fund program ("SLFRF"), and HUD's HOME program funds respectively. The Department of the Treasury's SLFRF Final Rule and Compliance Reporting Guidance detail multiple requirements and compliance responsibilities, as well as provide additional information on eligible and

restricted uses of Fiscal Recovery Funds and reporting requirements. Moreover, construction of less than twelve (12) units of housing in this Project will include federal financial assistance through HUD's HOME program, whose terms and conditions must be complied with as well to the extent applicable hereto.

Availability of Funds Limitation. The owner has received federal grant funds from the U.S. Department of the Treasury's State and Local Fiscal Recovery Fund program ("SLFRF") and HUD's HOME program funds respectively (termed for purposes herein the "Prime Awards") to carry out the underlying project. The continuation of the project and payments thereunder shall be subject to the availability of funds to NNCH under the Prime Awards. NNCH shall promptly notify Insurance provider, in writing, of any (i) termination of the Prime Awards or (ii) modification of funding available under the Prime Awards that might negatively impact NNCH's Agreement with Insurance provider and NNCH shall compensate Insurance provider for services performed prior to termination or funding modification.
